



NOTIFICATION OF INTENT TO INVITE BIDS

Ministry of National Defence of Romania intends to invite eligible companies to participate at „National Competitive Bidding +” („NCB+”) for technical design and implementation of works of the project 2018/3AF35021-00 - *PROVIDE AIRCRAFT PARKING PLATFORM at Mihail Kogalniceanu AirBase.*

The project is currently developed in the Capability Package CP 9A1385 – *Defensive and Offensive Air Assets in SACEUR’S AOR* and is commonly funded from NATO Security Investment Program.

1. **Summary Description of Project: 2018/3AF35021-00 - PROVIDE AIRCRAFT PARKING PLATFORM.**

The project 2018/3AF35021-00 - PROVIDE AIRCRAFT PARKING PLATFORM is required to provide the NATO required space for 17 TACAIR (17 TFA Group aircraft with maximum wingspan = 13.10m), through the re-construction of an aircraft parking platform, with runway access, drainage, lighting and day marking.

The main works:

1. TFA aircraft parking platform structure – dimension: 335 m x 85m
2. Jet blast deflector
3. Marking
4. Drainage
5. Airfield lighting system

“NCB+”

16. Bidding is conducted according to *G.E.O. no. 114/2011 approved by Law 195/2012 on the awarding of certain Public Procurement contracts in the field of defense and security* and is open to all bidders from NATO member countries (“**29B**”). Only eligible companies from NATO member countries (“**29B**”) are allowed to participate in the bidding “NCB+”.

All bids shall be accompanied by a Bid Security of 181.122,00 euro.

The contracting authority shall demand performance guarantee representing 10% of the overall value of the contract.

To qualify for award of the Contract, bidders shall meet the minimum qualifying criteria as specified in the bidding documents. For the qualified companies, the criterion for awarding the contract is **the lowest price criteria**.
